STREET TEAM TERMS & CONDITIONS

All Doheny Days Music Festival Street Team Applicants must read and accept the Terms and Conditions for The Doheny Days Music Festival Street Team.

The **Doheny Days Music Festival Street Team Service** (the "DD Street Team"), operated by Doheny Festivals Inc., and Omega Events Inc. (together, Doheny Festivals Inc. and Omega Events Inc. are referred to as "we", "us" or "our") is provided to you ("you," "your" or "User") under the following terms and conditions, including any amendments thereto and any additional terms and conditions, rules or policies that may be applicable to particular offerings made in connection with the DD Street Team (collectively, the "Terms and Conditions"). We reserve the right to update or change these Terms and Conditions from time to time. Any such changes shall be reflected in an updated version of the Terms and Conditions posted on our website. By continuing to use the DD Street Team following the posting of any such change, you will be deemed to have agreed to the amended version of the Terms and Conditions. Eligibility

Unless otherwise specified, participation in DD Street Team is open only to natural persons who are residents of Southern California and who are 18 years of age or older. Applicants located outside of Southern California, will be evaluated on an individual basis.

Expectations

Street Team members are expected to dress appropriately when completing their tasks. We suggest you dress comfortably and wear tennis shoes.

Reservation of Rights

The DD Street Team and its benefits are offered at our discretion, and we have the right to modify or discontinue, temporarily or permanently, the DD Street Team, including the email newsletters or contests offered, in whole or in part for any reason, at our sole discretion. We may, among other things, withdraw, limit, modify or cancel any contest or modify or condition the transferability of a prize offered in a contest. You agree that we will not be liable to you or any third-party for any modification or discontinuance of the DD Street Team in whole or in part.

Membership Registration

You agree to provide true, accurate, current and complete information about yourself as prompted by the application form and to maintain and promptly update your personal data to keep it true, accurate, current and complete. If you provide any information that is untrue, inaccurate, not current or incomplete, or if we or any of our service providers have reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, we have the right to suspend or terminate your application and to refuse any and

all current or future use of the DD Street Team (or any portion thereof) by you. You may not register with a disposable email address. Only one member account per person and two member accounts per household. If you are under 18 years of age you cannot complete the registration process.

Privacy Policy

By participating in the DD Street Team, you agree that we may collect and use information about you that you provide to us in accordance with our Privacy Policy. Doheny Festivals Inc. and Omega Events Inc. respects and is committed to protecting your privacy. Although we collect personally identifiable information, we use this information solely for the purpose of processing applications and managing the DD Street Team. Your information will never be sold, leased, transferred or traded.

Violation of the Terms

You understand and agree that in our sole discretion, and without prior notice, we may remove you from the DD Street Team if we determine that you have violated our Terms and Conditions.

Indemnity

You agree to indemnify and hold us, our subsidiaries, affiliates, officers, agents and other partners and employees, harmless from any loss, liability, claim or demand, including reasonable attorney's fees, made by any third party due to or arising out of your use of the website, including, without limitation, any information or content you post to the site or any interference with the operation of the site.

These Terms and Conditions shall be governed by and construed in accordance with the laws of the State of California, without giving effect to any conflicts or choice of laws rules (whether of California or any other jurisdiction).
